One of Michael's well-known reported decisions in *MacLeod v. Canadian Road Management Company*, 2018 ONSC 2186 was used by the Honourable Justice Myers as a platform to scrutinize the civil jury system and expand on the test for striking a jury notice. This decision has been cited numerous times by the Ontario Superior Court of Justice and the Court of Appeal and is one of the leading cases in this area.
